
I hope we all remember to be kind to each other. That sounds easy, but sometimes it isn't. People forget things, people say mean or

# to wash or not to wash...part 1

article from craftsy.com 'How to Wash Quilting Fabric by Carolina Moore

Some quilters like to wash all of their fabric before cutting it, other quilters prefer to use unwashed fabric. While there are definitely pros and cons to prewashing fabric, there are times when all quilters should wash their fabric. It's important to know when you really must wash and, when those times arise, how to wash quilting fabric to avoid ruining it.

#### YOU SHOULD WASH YOUR QUILTING FABRIC IF:

#### YOU PLAN TO DYE THE FABRIC

Most fabric dyes work best on fabric that has been washed to remove any chemicals left in the manufacturing process. Check the dying instructions on your fabric dye to see if you should pre-wash your fabric.

#### THE QUILT WILL BE GIVEN TO A BABY OR CHILD

Quilts given to a baby or child should be washed either before the fabric is cut, or after the quilt has been bound. This removes any chemicals or other residue from manufacturing that might irritate the sensitive skin of a baby or child.

#### YOU HAVE ALLERGIES

If you have skin allergies and find that you are sensitive to dyes in fabrics, you might want to wash the fabric before cutting to reduce or eliminate any reactions.

#### YOU ARE CONCERNED ABOUT SHRINK OR BLEED

If you plan to wash the quilt after it is completed, you may want to wash the fabric beforehand. Washing the fabric before cutting it will reduce the amount of shrink and wrinkles in the finished quilt when washed. However, some people like the vintage look that comes from washing a quilt pieced from unwashed fabric.

When using fabrics with high contrast (especially red and white combinations), washing your fabrics before stitching will reduce the color from later bleeding onto the light fabrics during washing or storing the quilt.

#### YOU ARE USING MATERIALS THAT REQUIRE PRE-WASHING FABRICS

Some materials, such as some fusibles used in appliqué, require prewashing the quilting fabrics before using the fusibles. Read the package instructions on any materials you use in your quilts.

#### YOU ARE MAKING A GARMENT

Every now and then, quilters make clothes instead of quilts. Prewashing fabrics before making a garment will take out the shrink, ensuring that the garment you make stays the size you stitched it.

#### **Tonight's Program - Lori Jones**

Sujita Shah - The Root Connection Sujita was raised in India and from a young age she has always been interested in art. She went to school to study graphic designs and this is where she developed an eye for patterns and textures. Sujita presented a slide show of her OCTOBER 2016 homeland of India, where she introduced us to their colorful, bold use of color, designs and textures. India is rich in all of these. She stated that she loved fabric but did not want to sew, she accompanied her mother to market to select the fabrics for their clothes. They would go to the local sari shops to find material for their clothing, it takes 6 yards to make one sari. She mentioned that the variety of architecture in India provides many ideas of patterns they can use to make wood blocks for printing.... they carved in 6 inch blocks of wood then print one block at a time on 8 yards of fabric and use indigo, wax, mud resistant dyes in making their designs. Quilt blocks are also on household items, pottery clay walls whatever they see as inspiration they would apply in daily life; unity in India is colors.

She moved to the United States (San Francisco) in 1986 and was met with grey dull colors, cold and dreary not what she was used to in her home of India which was rich in color, but to fit in she adapted to this culture and put away her colorful clothing and saved them for special times. In 1991 and after 2 children, she found in a local craft show handmade dolls this interested her greatly and began creating them. This led to trips to the fabric shops where she took a basic quilt making class and where she first begin designing with fabric and feeling good about it. She said every stitch made her feel good and remember her mother and her teen years in India. In 1996, she moved to Seattle, Washington she got into quilting full-time she needed to be an artist this is where she developed hand appliqué and taught herself how to use freezer paper. Her teacher told her in her hand appliqué class "it's your quilt and you can do whatever you want, just have fun and make it". She then moved on

to designing block of the month classes for Quilt Shops, she started designing patterns and making her own quilts. In 2002-03 her perspective on quilts changed when she discovered the book about the quilts of Gee's Bend, Alabama and the ralli quilts from India. These two cultures blended instantly in her brain and she knew she wanted more than just straight lines in her quilts, which became her free-form blocks. In 2007, they moved to Pennsylvania and really got going with the free-form blocks. She hand quilts because this puts life into her quilts. She uses quilts as her art, because graphic design uses color, design and texture. Sujita said if your heart is in creating then make something that's fun and create. She showed about 25 of her beautiful quilts, and each one had a wonderful story.

These are abbreviated board minutes. Rose Lawrence was unable to be there and I (Kathy Garringer) conducted the meeting and kept notes. This is the meeting in a nutshell.

Meeting was called to order at 5:50 pm by Kathy Garringer.

Jennie & Toni wish to resign their positions as retreat co-chairs. The board accepted their resignations. Jennie already has a tentative contract for next year with the motel and convention center. The board also briefly discussed whether or not to keep the retreat under the umbrella of the guild. It is a paperwork headache for the treasurer and only 15 members attended the retreat which is about 9% of our membership. The board decided to talk about this more in January.
