Vendor will be responsible for the conduct of all sales personnel in their booth. Vendor understands that décor and method of display are at the option of the vendor, within the bounds of good taste. Booth space shall be used for display, promotion, and the sale of goods handled by the vendor. Vendor understands and agrees that show management shall have the right and authority to close down and cease the operation of any vendor booth, without refund of any fees paid, for violation of any show rule, as determined solely by show management. Vendor hereby agrees to abide by show rules and to hold the show, its representatives, and officers harmless from any and all legal liability which may arise resulting from vendor's activities, actions or inactions at the show.
